Building a legal democratic state and the development of society depends on the high level of education and legal literacy of the growing generation. A necessary condition for building a legal state and civil society is the unconditional implementation of laws. Uniform and unconditional implementation of laws depends on the attitude of our jurists to their duties and feeling of responsibility.

Today, reforms are being implemented in our republic regarding the establishment of a legal democratic state and the formation of a civil society. Ensuring the rule of law, which are the most important signs of a legal democratic state, and raising a mature generation with a high level of legal awareness and culture are the core of these reforms.

In order for the meritorious works carried out in the Republic of Uzbekistan for the benefit of the youth to bear fruit, for our great ancestors and the future generation to fulfill their duties to their ancestors, high spirituality and It requires a high responsibility to have dignity, to feel a sense of belonging to history and, of course, to fulfill a constitutional duty. For this, it is necessary to develop concepts such as legal consciousness and legal culture in them. I believe that we will achieve the desired results by properly and systematically organizing the teaching of legal sciences.

Raising legal awareness and legal culture in society is one of the most important conditions for ensuring the rule of law and strengthening legitimacy.

In recent years, significant work has been done on the fundamental reform of the national legal system, the formation of legal culture in society, and the training of qualified legal personnel. Every member of the society should know his rights, duties and responsibilities thoroughly, understand this as a vital need. Changing the worldview and thinking of our citizens in accordance with the country's life and updates is closely related to the concept of legal culture.



President Sh.Mirziyoev in his book "New Uzbekistan Strategy" focused on the essence of the democratic reforms implemented in our country: "In recent years, as a result of socio-political reforms that covered all aspects of the life of our society and were implemented gradually, the way of thinking and worldview of our people changed. "along with the changes, the working methods and directions of the management officials and officials began to acquire a new quality and modern content".

Decree No. PF-5618, adopted by our President on January 9, 2019, "On the fundamental improvement of the system of raising legal awareness and legal culture in society" was an important document that defined the important tasks ahead of us in this direction.

Its significant aspect is that the existing shortcomings in this direction are indicated one by one in the decree. As noted in the document, we cannot say that today there is a comprehensive approach to the work of instilling respect for laws and rules of etiquette in the population, and instilling a sense of intolerance towards violations. Inadequate work of inculcating the ideas of maintaining a balance between personal interests and the interests of society into the minds of the population has a negative impact on ensuring the rule of law. Recently, it has been observed that in various regions of our republic, articles are published on the global information network about cases of discrimination of citizens' rights by officials. The root cause of these negative situations is the lack of legal knowledge among citizens.

In addition, the legal education and upbringing of young people in order to improve legal culture is not carried out systematically and organically. For many years, this issue has been viewed as the work of law enforcement agencies and educational institutions, and the participation of family, neighborhood and civil society institutions has not been sufficiently ensured. To put it bluntly, promotion activities are often limited to the organization of ineffective seminars, roundtables and similar meetings, and it is clear that innovative methods are not used enough in the promotion process. This has a negative impact on the development of our society. There is no comprehensive approach to the formation of legal immunity to factors that negatively affect the legal education of young people, respect for laws and rules of etiquette, loyalty to national values, and intolerance to violations. The level of legal consciousness and legal culture is determined not by the number of laws adopted, but by the full implementation of these laws. In this important work, it is of particular importance to educate people to respect laws and regulatory documents.

Based on these criteria, the decree states that "establishing respect for laws in society is the key to building a democratic legal state!" It is emphasized that one of the primary tasks is to strengthen the vital idea, to form a system of consistently conveying to the population the content of the socio-economic reforms, adopted laws and state programs.

Based on this, the National Strategy on Human Rights was adopted on June 22, 2020. The purpose of the strategy is to determine the main tasks and directions of the implementation of the state policy of ensuring human rights and freedoms in Uzbekistan. The priorities of the national strategy:

- Protection of personal and political rights,
- Protection of economic, social and cultural rights and sustainable development,
- Improvement of implementation and monitoring mechanisms,



- Increasing legal literacy in the field of human rights,
- Development of international cooperation in the field of human rights protection.

In this case, the raising of legal consciousness and legal culture in the society is systematically and organically organized according to the principle of "person - family - neighborhood - educational institution - organization - society". In fact, nothing can compare to legal education in terms of importance in inculcating the fundamentals of law, the essence of the Constitution and laws, new legal documents, legal standards into the minds and hearts of people, first of all, young people.

In particular, we are a targeted measure aimed at forming and developing a legal culture in society, fundamentally improving legal education and knowledge promotion in our country, delivering the adopted regulatory legal documents to the executors, and making the population widely aware of the purpose and content of the adopted laws. - We support events. After all, only a citizen who is free, knows his rights and obligations, respects the law and current procedures can fully enjoy his rights. At this point, I think it is permissible to mention one comment. Today, the issue of developing our laws in a simple language that ordinary people can understand is also urgent. Draft laws should be prepared in Uzbek and then translated into Russian. In practice, due to the fact that a number of draft laws were prepared in Russian and then translated into Uzbek, some sentences in it remain unclear and unclear.

In addition, it would be appropriate if the name of the website, which conveys legal documents to the population, is expressed in Uzbek language in a short sentence. For example, the name of the portal for the discussion of draft normative legal documents of the Republic of Uzbekistan - [www.regulation.gov.uz](http://www.regulation.gov.uz) - may be understandable for experts and intellectuals, but it is difficult to say that it is memorable for ordinary citizens. Considering that the majority of the population of Uzbekistan speaks the Uzbek language, we believe that if such public interactive portals are named in Uzbek, they will be understandable to everyone. Including, it would be appropriate to name the legal information system (Advice.uz) in Uzbek, which includes the portal for free advice to the population, established according to the concept of raising legal culture in society. An example in this regard is the fact that the name Meningfikrim - Community Appeals Portal ([www.meningfikrim.uz](http://www.meningfikrim.uz)) is widely popular among a wide segment of the population, especially among young people. Therefore, there is no need for the name of Uzbek-language websites to be in English. In other words, the fact that many people read the information and explanations on legal topics on these sites is to some extent related to this factor.

In conclusion, timely implementation of the important directions and tasks of raising legal awareness and legal culture in the society defined by the decree requires responsibility and self-sacrifice from us, lawyers and intellectuals. After all, as the head of our state said, "Rule of law and ensuring human interests are the guarantee of the country's development and people's well-being."
