Chapter 1 Passed by the Legislature on May 19, 2020 Approved by the Senate on August 7, 2020. General rules Article 1. Purpose of this Law The purpose of this Law is to regulate relations in the field of education. Article 2. Legal documents on education Legal documents on education consist of this Law and other legal documents. If the international agreement of the Republic of Uzbekistan stipulates different provisions than those stipulated in the legislation of the Republic of Uzbekistan on education, the provisions of the international agreement shall be applied. Article 3. Basic concepts The following basic concepts are used in this Law: state accreditation - state educational standards and state education the process of state recognition of compliance with the requirements and educational programs and the provision of the right to submit information documents to their graduates; state educational institution - an institution established by state authorities and management bodies on the basis of state-owned property, providing education in accordance with state educational standards and state educational requirements; state education standards - a set of requirements set by the state regarding the content and quality of education; state educational requirements - mandatory requirements for the structure, content and conditions of education, as well as physical, personal, intellectual, scientific and professional qualities of learners; qualification - the level of knowledge, ability, skill and skills, which expresses a person's readiness to perform a certain type of professional activity, confirmed by an appropriate document on information; specialty - the name of a specific type of professional training that ends with the awarding of a



qualification; non-governmental educational organization - a legal entity providing educational services based on a license that gives the right to provide educational services in accordance with state educational standards, state educational requirements and curricula; education is a systematic process aimed at the comprehensive development of the young generation, the formation of their consciousness, spiritual and moral values and outlook on the basis of specific goals and socio-historical experience; education is a systematic process aimed at providing students with in-depth theoretical knowledge, skills and practical skills, as well as forming their general and professional knowledge, skills and abilities, and developing their abilities; educational campus - educational buildings, research institutes (centers), production complexes and technology parks, temporary residences of participants of the educational process, laboratories, information and resource centers (libraries), sports facilities united in a single area, an educational-educational environment, consisting of a complex of buildings and structures including catering facilities, which ensures the high efficiency of the educational process, spiritual and moral education; participants of the educational process - learners, parents or other legal representatives of minors, teaching staff and their representatives; attestation of educational organizations is the main form of state control for evaluating the activities of educational organizations, determining the content, level and quality of personnel training in accordance with state educational standards, state educational requirements and educational programs.
