Today, this unique management structure is a proof that the role and influence of the independent institution in the socio-

Also, the implementation of public control over state bodies and citizens by self-governing bodies serves as a basis for the real priority of democracy in society. In this regard, President Sh. Mirziyoyev said, "... When will the state successfully fulfill its mission? when there is effective public control over the activities of state agencies" [2]. In fact, since 2017, the activity of selfgoverning bodies has risen to its updated level, according to the President of the Republic of Uzbekistan Shavkat Mirziyoyev on February 7, 2017, in 2017-2021 "Five priority areas of development of the Republic of Uzbekistan The first priority direction of the Decree No. PF-4947 "On the Strategy of Actions for the Development of the State and Society" dated January 28, 2022 "Development Strategy of New Uzbekistan for 2022-2026" in the first of the 100 goals defined in Decree No. PF-60, that is, to increase the effectiveness of the activities of the Neighborhood Institute, to turn it into a support link of public management and control, to solve socio-economic problems in the regions on the spot expanding the powers of neighborhoods, strengthening their financial independence, ensuring the participation of citizens in the life of their neighborhood and direct communication between state bodies and neighborhoods, digitalization of processes aimed at working with residents in neighborhoods, starting from the neighborhood to create a system of applying to all state agencies, to provide state and social services directly in the neighborhood, to strengthen the state support system based on the "growth points" of the neighborhoods and the specialization of the population living in them in business activities, to hire highly qualified specialists for the neighborhoods targeted training, formation of skills in management fundamentals, employment provision, banking and finance, real estate, land, animal husbandry and poultry farming in all neighborhood chairmen and deputy mayors. Tasks such as establishing the effective activity of the district (city) mayor's assistant institute [3] on the issues of entrepreneurship development, ensuring employment of the population and reducing poverty have been defined, which will stimulate the effective activity of the neighborhood institute. Article 7 of the Constitution of the Republic of Uzbekistan states that "People are the only source of state power in the construction of civil society. State power in the Republic of Uzbekistan is exercised only by bodies authorized by the Constitution of the Republic of Uzbekistan and the laws adopted on the basis of the interests of the people. Appropriation of the powers of the state power, suspending or terminating the activities of the authorities, creating new structures of the government in a manner not provided for by the Constitution is considered a violation of the Constitution and is the basis for prosecution according to the law [4] - emphasizing that it is the only source of state power implies strengthening the activity of self-government bodies from a political and legal point of view.



Mahalla is a democratic institution that serves primarily to ensure the peace of citizens, the strength and well-being of families, to raise young people into a well-rounded generation, to improve our social and spiritual life, and it leads the Uzbek people to a single goal.
