Let's take a look at the statistics together with you, World Health Organization (WHO): Every year WHO publishes its report showing the number of victims of physical violence. According to data provided by WHO in 2020, more than 1.3 million people worldwide experience physical violence every year. We need to look back 7 years from these statistics to get acquainted with the information explained in concrete numbers: Internationally, violence caused the death of approximately 1.28 million people in 2013, compared to 1.13 million in 1990. However, the fact that the world's population has increased by about 1.9 billion people over the past years shows that the level of violence per capita has decreased dramatically. In 2013, approximately 842,000 deaths were related to self-harm (suicide), 405,000 to interpersonal violence, and 31,000 to collective violence (war) and legal intervention. Of the nearly 405,000 deaths from interpersonal violence worldwide in 2013, 180,000 were assaults with firearms, 114,000 were assaults with sharp objects, and the remaining 110,000 were from other causes. In addition, there are cases of





violence against young children.

Child abuse statistics show that the rate of child abuse in America (USA) is very high. In one year, there were 3.3 million reports of 5.9 million child abuse. Every year in America (USA) children of different ages and different types are subjected to violence. In fiscal year 2010, approximately 9.2 per 1,000 children were found to have been abused (some children were abused more than once during that year). Other child abuse statistics include: Victims under the age of one had the highest rate of child abuse, with over 2% of children becoming victims of child abuse. Girls are victims 51.2% more often than boys. 88% of victims belong to the nationality:

Maternal mortality (per 100,000) -29 (2017) Women in government -33% (2021)

Women over 25 with secondary education - 64.8% (2017)

Women in the labor force - 39.44% (2021) In addition, it is no secret that violence against women and children is also committed against men. For example, in recent days, the violence committed several years ago in America (USA) has been revealed.

- Stress and emotional states: Violence can often be the result of personal stress or emotional states. For example, depression, isolation, or being under extreme physical or psychological pressure can lead to violence.
- Age-related characteristics: Certain age groups (for example, teenagers) are emotionally unstable, which makes them more likely to turn to violence.
- Family violence and personal experiences: If a person was abused as a child or teenager, they may be predisposed to use violence themselves. This is called the phenomenon of "learned behavior".

The second reason is social and cultural factors:

- Stereotypes and gender roles: Cultural and social practices such as specific gender stereotypes, keeping women or men in their place, gaining power and discriminating against others can lead to violence. Sometimes men try to show their superiority to increase violence against women or other men.
- Inequality in society: Socio-economic inequality, the fact that one group or class is stronger or wealthier than another, as well as the existence of social acceptance of inequality, can increase



violence. Early studies show that economic hardship (such as unemployment or poverty) often leads to violence.

- National or ethnic conflicts: Conflicts between ethnic, religious or national groups can lead to violence. Conflicts, wars, and ethnic clashes are among the main causes of violence.

In order to prevent this type of crime against young children in Uzbekistan, a lot of promotional work and legislative documents are being adopted. For example: the Law of the Republic of Uzbekistan "On the Protection of Children from All Forms of Violence", which is expected to enter into force on May 15, 2025. In addition, in 2021, about 40,000 women who suffered from harassment and violence were issued protection warrants in Uzbekistan. The UN has developed guidelines to protect women from violence, including the International Campaign to End Violence Against Women and the Roadmap to Prevent Violence. Proposal. Article 19 of the newly revised Constitution of the Republic of Uzbekistan states that all people have equal rights and obligations, and Article 78 stipulates that fatherhood is protected in the same way as motherhood. In addition, other norms also emphasize the equality of men and women. . It is necessary to protect men from violence together with women in the documents that are being adopted under the law and in the organizations that are expected to be established. For example, in Great Britain, men who have experienced violence can get advice and help by
