Introduction

In particular, the first article of our Constitution defines "Uzbekistan is a sovereign democratic, legal, social and secular state with a republican form of government". Accordingly, the analysis of the concepts of "secular" and "religious" proportionality, the study of their interrelationships and differences is of great importance.

Secularism is a principle in the organization of political power and administrative governance, the historical roots of which go back to tolerance. In order to ensure social peace, democratic states under the rule of law assume the responsibility to simultaneously fulfill two main tasks: to guarantee freedom of conscience and religion to each individual and, at the same time, to ensure the equality of all 2 .

It is not correct to completely contrast the concept of secularism with religiosity³, emphasizes Nuriddin Hoji Holiqnazarov. In a certain sense, religiosity and secularism are not completely contradictory concepts. They are different ways of looking at the essence of the world and human life. The concept of secularism includes the principle of separating religious organizations from political organizations and not making religiosity the basis for everything. Religiosity is a feeling that depends on the heart. Forcibly instilling it in everyone does not correspond to any religious principles. In countries that have followed the path of secular development, although religion is

separated from the state, it is not separated from society. National and religious values are important parts of the spiritual image of peoples.

In Islam, secularism is not considered a concept alien to religion. We can also see the basis of the principles of secularism in the sacred sources of Islam - the Holy Quran and the Sunnah. For example, in Surah Al-Baqarah, verse 201: And there are those who say: "Our Lord, give us good in this world and good in the Hereafter, and save us from the punishment of the Fire."

This verse indicates that a person should also work for this world. The verse in the Holy Quran, "There is no compulsion in religion" (Al-Baqarah, 256), embodies one of the most important foundations of secularism. According to it, it is impossible to force a religious lifestyle. It is also noteworthy that this verse is one of the last verses to be revealed.

Also, the verse in Surah Al-Qasas, which states: "And seek the Hereafter with what Allah has given you, and do not forget your share of this world" (Qasas, 77), was interpreted by Abu Layth Samarkandi as "Do not abandon your share of this world, so that it may serve you in the Hereafter."

This verse says that while remembering the Hereafter, do not forget the blessings of this world. Because you have the rights of your body, your family, your neighbors, society, and those under your control, and you must fulfill the rights of everyone who has the right⁴.

Indeed, religious tolerance is based on the respect of individuals for different religious beliefs and traditions. This principle serves to build tolerance and harmony in society. All religions in the world promote moral and spiritual principles that are accepted by their followers. These values are recognized as moral standards in personal and social life. By supporting religious tolerance, mutual respect and cooperation between different faiths in society are strengthened. For example, in European countries, special laws and regulations have been introduced for the coexistence of representatives of different religions. Such procedures create favorable conditions for all groups to protect their rights and practice their faith in collective and social life.

MAIN PART

Freedom of conscience and religion only requires that people be free, equal before the law, that state institutions and officials be
